Ownership of a Beaver coach, membership in FMCA and a desire for fun and friendship are qualifications for BAC membership.

**Complimentary Membership:** First-time owners of a brand new (not used) Beaver coach that has not been registered are entitled to a first year complimentary membership in BAC. If you qualify for the complimentary first year BAC membership, and are not a current or former FMCA member, the first year FMCA dues will be paid compliments of Beaver Motor Coaches, a division of Monaco Coach Corp. **Applications must be returned to the Membership Director within one year from the date the sale is recorded in order to participate in the Complimentary Membership package.**

**Dues:** If you do not qualify as the first-time owner of a new coach: First year, \$40, which includes name badges and computer mailing setup. Dues following first year, \$30 annually. All applications received after June 1 apply to the following fiscal year (October 1 to September 30). Please include additionally: Canada - \$3, International - \$5, payable in US funds.

BAC membership requires current FMCA membership. If you are not currently an FMCA member, please complete the FMCA application on the reverse side. Include a \$45 check payable to FMCA along with your completed BAC application with a \$40 check payable to BAC. The BAC Membership Director will process both applications.
